# WE KNEW BEFORE BOB DID THAT HE WAS BEING SUED AGAIN!



**T**HE ENQUIRER reported back in June that Bob Barker would be slapped with yet another sexual harassment lawsuit, this time by former "Price Is Right" model Claudia Jordan.

Once again, The ENQUIRER had the news first — even before Barker!

The suit — for wrongful termination, sexual harassment, hostile working environment, race discrimination, and intentional infliction of emotional distress — was filed on August 3, also on behalf of Sylvia Clement-Henry, a show consultant.

Barker, 80, has hosted the popular game show for 32 years, and has won 16 Emmy awards. In June, he was inducted into the Academy of Television Arts & Sciences Hall of Fame.

But "The Price Is Right" and its host have a long history of being sued by models and employees of the show —

including Holly Hallstrom, Dian Parkinson, Sherrell Paris, Sharon Friem and Linda Riegert. Barker settled Sherrell's and Sharon's lawsuits out of court, and Dian dropped hers.

Holly is still awaiting a court date, and Linda's case is expected to hit the courtroom this fall.

In the lawsuit, Claudia charges that Barker created a hostile working environment and an atmosphere of terror in the workplace.

Claudia, who left the show last October, claims she continues to suffer severe emotional distress.

Barker, a tireless crusader for animal rights, intends to vigorously fight Claudia's suit.

His attorney Patricia Glaser told The ENQUIRER, "In our view, there's absolutely no truth to these allegations regarding Mr. Barker. They are not supported by fact."

But Nick Alden — the lawyer for Claudia, Sylvia, Holly and Linda — told The ENQUIRER, "In my view, these lawsuits are an indictment of Bob Barker and his behavior over the last 10 years."
