MIKE TYSON IN NEW RAPE SCANDAL

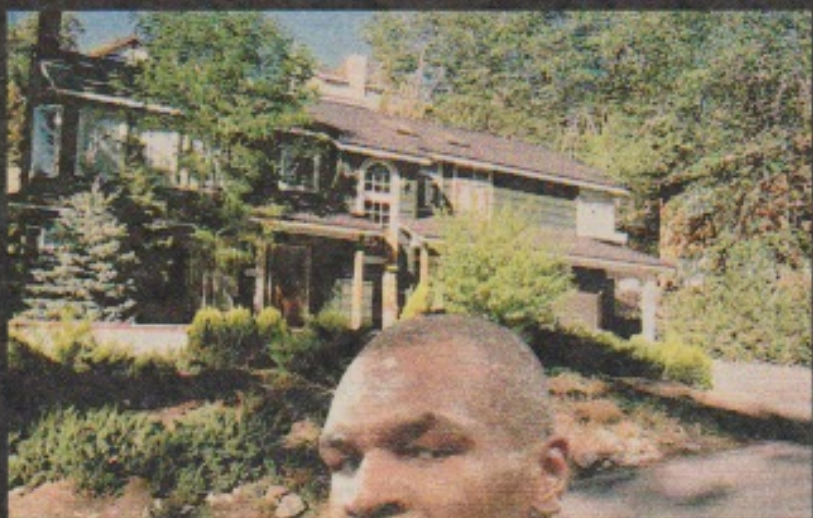
woman Mike Tyson is
sed of raping in his latest
scandal is a 50-year-old
grandmother, insiders reveal.
In an exclusive interview, a
friend of the alleged victim
reveals the shocking details
of the new rape charge. GLOBE
has the name of the woman, but
Tyson is chosen not to reveal it and,
we call her Alice.
The 50-year-old former heavy-
weight definitely had sex
with Alice on July 16, while he was in
Big Bear Lake, Calif., training for
his fight with the pal. And Alice,
with three grandchildren, was
so badly that she had to be

up by a doctor in the
area.
Alice is very shaken when she
talks about her encounter with
Tyson, a friend says.
"I didn't need stitches
because she said she also needed to
see a psychiatrist," confides the
friend.
Tyson seemed very distraught.
"The size of Mike was so huge that
I was terrified of her. She said she was
all over and was really
crying when she went to a doctor,
and they put her up."
The following day, the doctor
performed the alleged assault
at a Bernardino Sheriff's
station, as required by law.
The sheriff's office then inter-
viewed Tyson.
Tyson, who served three years
in prison after being
convicted of raping a teen beauty
in a hotel room in 1992, was
not known in the community about
his fight out of L.A., training for a
fight with the pal. He met Alice at
a gym where she works.
Tyson's pal

He walked up to her and
referred to her as your big Southern
booty friend. "Then he
asked if he could see her

sometime." Alice was unsure about
hooking up with the boxer, who is
estranged from his physician wife
Monica Turner, but her family

urged her to do it because he is rich
and famous.

"The next day, she went to the
house he was renting at the foot of

the mountains," the insider says.
"Soon after she arrived, they ended
up in bed.

"Alice told me, 'We had sex in
the bedroom with the door wide
open.' She said all his friends were
hanging out just outside the room
and Mike was worried that he
was cheating on his training
regime. He said, 'I'm in training I
shouldn't be doing this.'"

Now, lawmen say they are
investigating the alleged incident at
the posh \$4,200-a-week house and
want to question the fighter, who's
since moved his training camp to
Phoenix, Ariz.

Tyson's attorney, Darrow Soll,
denies that there was any force
involved. "We feel the allegation is
without merit," Soll declares. "We
expect Mr. Tyson to be cleared of
any wrongdoing."

And one of Tyson's boxer pals
says, "Everyone is out to set up
Mike. They know he's vulnerable
and has a hell of a lot of money."

While in California, the fighter
worked out at Big Bear Fitness, par-
tied at several local nightspots and
also rented sexy flicks from the local
Blockbuster video store, sometimes
more than 10 a day, with titles such
as Kill or Be Killed, Sexual Intrigue
and Love Beat the Hell out of Me.

But the champ's stay in Big Bear
Lake was marred by controversy
even before the rape allegation. He
was also accused of stealing \$25
worth of candy from a store.

Sources say the incident was a big
misunderstanding and settled to
everyone's satisfaction.

"Mike never carries cash or credit
cards," explains an insider close to
the boxer. "He is used to his
entourage taking care of everything.
When he realized he had picked up
some things and walked out of the
shop without paying, he went back
the next day."

Tony Perillo, part owner of the Big
Bear Candy Co., tells GLOBE, "He
apologized and actually was very
sweet. We were paid what was owed
us — and that was that."

Now, Tyson's pals claim that the
new scandal will also be settled in
the fighter's favor.
